**NOW, THEREFORE, BE IT RESOLVED:** That the Montana State Knights of Columbus, and its members, stand firm with the Bishops and support them with prayer to the Blessed Mother; and

**BE IT FURTHER RESOLVED:** That the Montana State Knights of Columbus advocates for all Councils in Montana and all Catholics in Montana to pray the Rosary for the intentions of the Bishop of the Diocese of Helena and the Bishop of Great Falls- Billings on September 8th, the Nativity of Mary or at the monthly Council Meeting closest to September 8th.

**RESOLUTION No. 4 – Submitted by the State Officers.**

**WHEREAS:** The Montana Knights of Columbus desires to support Catholic Higher education in Montana;

**NOW, THEREFORE, BE IT RESOLVED:** That, depending upon funds being available, \$2,000.00 is hereby appropriated to be distributed as follows: one \$1,000.00 scholarship to be used at the University of Providence, Great Falls, Montana, and one \$1,000.00 scholarship to be used at Carroll College in Helena, Montana. Scholarships shall be awarded to practical Catholic students who are residents of Montana and who are attending or have been accepted to attend the University of Providence, Great Falls, Montana, or Carroll College, Helena, Montana. No division of these scholarships shall be made. These scholarships are for one year, to be granted in the fall of 2025 in the name of the Montana Knights of Columbus; and

**BE IT FURTHER RESOLVED:** That the funds for these scholarships shall be sent to the financial aid officers at the respective colleges who shall select the recipients and award the scholarships in accordance with the provisions of this resolution; and

**BE IT FURTHER RESOLVED:** That the names of the individual recipients be forwarded to the State Secretary of the Montana State Council by the financial aid offices at the respective colleges for recognition at the next state convention.

**WHEREAS:** The Montana Knights of Columbus State Council has named a State Director of Evangelization and Faith Formation and created a COR Team who have been trained by the Supreme Council to promote the adoption of the COR Meeting by local councils;

**NOW, THEREFORE, BE IT RESOLVED:** That the Montana Knights of Columbus State Council; its officers, directors, and district deputies inclusive, will promote and encourage the participation of each local council to adopt the COR Meeting initiative for the benefit of their brother Knights and their councils, and

**BE IT FURTHER RESOLVED:** That the Montana COR Team will collect and provide feedback to the Supreme Council during the pilot phase of the COR Meeting initiative for the benefit of the overall program rollout.

**RESOLUTION No. 7 - Submitted by Havre Council #1644**

**WHEREAS:** One or more District Deputy's travel a great distance to attend Council meetings with no compensation for the wives. Meals come out of the District Deputy's own pocket.

**WHEREAS:** District Deputy's often don't get home until very late or have to spend the night especially in the winter months. The District Deputy should not travel alone. Officers and State Officers often travel to the two state meetings and the state Convention every year and should be compensated for their wives.

**NOW, THEREFORE, BE IT RESOLVED:** that spouses of the District Deputy be given a stipend for meals when travelling to their Districts. The suggested stipend is no more than \$20 to help the District Deputy's and state officers pay for a meal for their wives.
